



BIOGRAPHY OF FREDERIC E. TEBOUL

SVP | Global Diplomat | Strategic Advisor | International Negotiator

Fred Teboul is a seasoned global professional, a trained attorney and a serial entrepreneur with dual citizenship in France and the United States, enriched by extensive experience across four continents. Born in Marseille, raised in Monaco and presently living between New York and Paris, he has developed a deep commitment to diversity, language proficiency, and cross-cultural collaboration—principles that have underpinned his 25-year career in government, business, philanthropy, advocacy and public policy.

Fred Teboul's academic background reflects his dedication to excellence and lifelong learning. He earned a Bachelor's degree in Law and Finance from Aix-en-Provence University, followed by a Master's in Political Sciences from the Paris Sorbonne University. He further enhanced his expertise with a post-master's degree in Public International Law—receiving top honors for his thesis—and a Ph.D. in Economic Development from École des Hautes Études en Sciences Sociales. In addition, he completed an Executive MBA in Management at the Athens University of Economics and Business. Fluent in English and French and proficient in several other languages, he combines rigorous academic training with a broad international network, a practical operational experience and a real passion for advocating.

Fred Teboul's professional journey began in 1995 as an intern at the French Ministry of Economy, followed by roles at the Ministry of Foreign Affairs and various French embassies. From 2000 to 2008, he held managerial positions within the United Nations in New York, Geneva, and Athens, where he supported UN initiatives, governmental programs and capacity-building projects through Public-Private Partnerships, acting as Senior Advisor to former UN Secretaries-General Kofi Annan and Ban Ki-Moon. He also drafted UN reports to improve partnerships with Governments, private sector and civil society.

Fred Teboul further broadened his leadership experience as Social Responsibility Director for a Greek multinational, establishing and managing a Public-Private Partnerships Fund that mobilized €360 million for CSR initiatives across the Mediterranean region. He later served as Secretary General of the Prince Albert II of Monaco foundation and as Deputy Chief of Staff at the Royal Palace of Monaco, where he engaged in high-level negotiations with government leaders to coordinate international projects.

In 2012, Fred Teboul joined the European Union institutions as a Senior Consultant, focusing on enhancing economic ties and supporting legislative activities. In 2014, he founded “Global Lobbying and Trading Partners”, a strategic advisory firm that has partnered with High (HNWI), Very High (VHNWI) and Ultra High (UHNWI) Net Worth Individuals as well as global organizations to improve their positioning strategy and execute resource mobilization strategies, raising US\$2.6 billion over a decade. He also established “Yes You Can”, a strategic communications firm that assists executives, corporations, and institutions in designing and implementing successful political campaigns and sporting event bids.

Moreover, Fred Teboul has contributed to a range of diplomatic, government, legislative, business, sports and philanthropic initiatives, including involvement in four Nobel Peace Prize-winning positioning strategies for the United Nations (2001), former U.S. Vice President Al Gore (2007), the European Union (2012), and former Colombian President Juan Manuel Santos (2016). He has also played a role in founding several institutions, such as the Muslim-Jewish Congress, the United Football Group, a Paris-based European real estate consortium, the ICANN regional headquarter in Europe and in Africa, as well as the United Nations COVID-19 Task Force. More recently, he co-established “My Peace Center,” a dynamic hub dedicated to peace-building, peace-keeping, peace-making and peace-education.

Fred Teboul’s blend of strategic insight, operational experience, work ethic, as well as his management, analytical, communication, and diplomatic skills positions him as a reliable SVP, right-hand executive, Chief of Staff, strategist, or senior advisor. His extensive background in negotiating with government leaders, senior partners, and high-net-worth stakeholders—coupled with a global network and a solid understanding of political and geopolitical dynamics—makes him well suited to support international growth, positioning strategy, policy advocacy, and high-level relationship building. He has been also awarded prices, lectured in forums and contributed to several international reports.

With a steadfast commitment to integrity, respect, accountability, and professionalism, Fred Teboul is recognized as a trusted advisor by governments, corporations, and foundations worldwide as well as a king-maker appreciated by former and current world leaders in the US, Europe, Africa and the GCC.
